

# Bachelor of Commerce/ Bachelor of Laws (Honours) 2024 Dual Program Structure

It is important that you read and understand the following information.

To be eligible to enrol in a dual degree program you must ensure that you satisfy the entry requirements for both programs.

Once enrolled it is your responsibility to ensure that you complete all the requirements for each section of this dual program in order to graduate with both degrees. The following information is designed to help you plan your enrolment to meet this goal. **Please note:** Students exiting early with one component of a dual program must complete the single program requirements of that component. Students will then be required to follow the single program requirements to complete the remaining component from that dual program and maximum credit rules will apply.

## **PROGRAM GUIDELINES**

You must complete 80 units, comprising –

- 30 units from the BCom component, including –
  - 14 units for all BCom Core Courses for the BCom/LLB(Hons); and
  - 16 units for a BCom Major from BCom Majors for BCom/LLB(Hons); and
- 48 units from the LLB(Hons) component, including –
  - 36 units for all LLB(Hons) Core Courses; and
  - 12 units from LLB(Hons) Flexible Core Courses; and
- 2 units of General Elective Courses

### **Note:**

- LAWS5144 must be completed if taking an Accounting major (for professional accreditation purposes)
